

Official Rules for Creative Getaway

NO PURCHASE IS NECESSARY. ENTRANTS MUST BE LEGAL RESIDENTS OF THE UNITED STATES AND EIGHTEEN (18) YEARS OF AGE OR OLDER. THE FOLLOWING PROMOTION IS INTENDED FOR VIEWING IN THE UNITED STATES (THE "ELIGIBILITY AREA") ONLY AND SHALL BE CONSTRUED ACCORDING TO KENTUCKY LAW. DO NOT PROCEED FURTHER IN THIS SITE IF YOU ARE NOT LOCATED IN THE ELIGIBILITY AREA.

- 1. ELIGIBILITY:** All entrants must be at least eighteen (18) years of age and legal residents of the Eligibility area. The first and last name provided by online entrants will be the identity of the entrant and, if selected and qualified for the prize, the identity of the winner. If a potential winner has not responded to the Paducah Convention & Visitors Bureau within the specified seven (7) days, the potential winner will be disqualified and an alternate may be selected from the pool of eligible entries. If an entrant is found to be ineligible, he/she will be disqualified and an alternate winner will be selected from the pool of eligible entries. Prize is non-transferable and must be accepted as awarded. No cash alternative or other substitution allowed.
