

Official Rules for Celebrate Quilting Giveaway

NO PURCHASE IS NECESSARY. ENTRANTS MUST BE LEGAL RESIDENTS OF THE UNITED STATES AND EIGHTEEN (18) YEARS OF AGE OR OLDER.

ALSO, THE FOLLOWING PROMOTION IS INTENDED FOR VIEWING IN THE UNITED STATES (THE "ELIGIBILITY AREA") ONLY AND SHALL BE CONSTRUED ACCORDING TO KENTUCKY LAW. DO NOT PROCEED FURTHER IN THIS SITE IF YOU ARE NOT LOCATED IN THE ELIGIBILITY AREA.

1. ELIGIBILITY: All entrants must be at least eighteen (18) years of age and legal residents of the Eligibility Area. Employees of the Paducah Convention & Visitors Bureau, their advertising agency and/or promotional partners and members of their immediate family (defined as parents, children, siblings, and husband or wife) together with those with whom such employees are domiciled are not eligible to enter.

2. TIMING: The Giveaway begins on December 9, 2009 and ends at midnight October 31, 2010

3. HOW TO ENTER: To enter, complete and submit the online Giveaway entry form located at <http://www.celebratequilting.com>. All entries must include entrant's name, state/zip code/country, daytime telephone number, and email address. The first and last name provided by online entrants will be the identity of the entrant and, if selected and qualified for the prize, the identity of the winner. The use of a bogus name or e-mail address will disqualify an entrant. There is a limit of one (1) entry per e-mail address, per person and/or per family or household. Any duplicate entries, after the first entry, will be void. By entering the Giveaway, entrant consents to receiving additional Paducah Convention & Visitors Bureau promotional information. All entrants agree to abide by these Official Rules. All entries become the property of Paducah Convention & Visitors Bureau. In the event of a dispute, the "entrant" for e-mail entries is the person in whose name the e-mail account is held.

4. PRIZES: One (1) winner will be selected by a random drawing on or about two days after the contest date has expired (October 31, 2010) from all eligible online entries received by Paducah Convention & Visitors Bureau by midnight (CT) on the day and time the promotion expires.

5. The potential Grand Prize winner will be notified by telephone, email or mail by a representative of the Paducah Convention & Visitors Bureau. The potential Grand Prize winner will be given seven (7) calendar days from the first time/day of notification to respond to the Paducah Convention & Visitors Bureau in order to claim his/her prize. If a potential winner has not responded to the Paducah Convention & Visitors Bureau within the specified seven (7) days, the potential winner will be disqualified and an alternate may be selected from the pool of eligible entries. If an entrant is found to be ineligible, he/she will be disqualified and an alternate winner will be selected from the pool of eligible entries. Prize is non-transferable and must be accepted as awarded. No cash alternative or other substitution allowed. Except where prohibited by law, participation in the Giveaway shall constitute an entrant's consent to be bound by these Official Rules and to conform to all federal, state and local laws. By participating in this Giveaway, entrants agree that Kentucky courts shall have jurisdiction over any dispute or litigation arising from or relating to this Giveaway.
